Financial Exploitation



Signs of Suspicious Financial Activities

- o Frequently changing accounts from one office, agent, or bank to another
- o Changes in patterns of withdraws (several in one day or unusually large amounts)
- o Large withdraws or transfers from recently opened accounts or previously inactive accounts
- o Frequent ATM withdraws when the elder is homebound
- o The elder's signature appears forged on checks, withdraw slips, or applications
- o Changes of beneficiaries in property titles, Wills, or other legal documents
- o Bank or account statements and correspondence is no longer going to the elder's residence
- A Financial Power of Attorney is executed by an elder who appears confused, forgetful, or has short-term memory loss

Perpetrator Examples

- o Borrowing money (sometimes repeatedly) and not paying it back
- o Denying services or medical care to conserve funds
- o Giving away or selling the elder's possessions without permission
- Misusing ATM or credit cards for the perpetrator's benefit without elder's knowledge or permission
- o Doling out the elder's money to family/friends without the elder's permission
- Taking or misusing an elder's property, money, Social Security or pension check, food stamps, medications, etc.
- o Misuse of Financial Power of Attorney or Conservatorship
- Identity Theft
- Scams/Fraud
- Coercion or using undue influence into signing or changing legal documents (Wills, land, assets, etc.)

Signs of Suspicious Behavior

- o Elder is accompanied by family, friend, or stranger and withdraws a large amount of cash
- o Individual with elder is "too" interested in the elder's finances
- o Elder appears nervous, afraid, or not allowed to speak
- Elder is concerned or confused about missing money in their account
- Elder is unable to remember questions, financial transactions, or signing paperwork
- o Elder appears to be neglected or is receiving insufficient care given their financial status
